

ULTIMATE CHEER LUBBOCK POLICIES AND PROCEDURES

Registration Fees:

An individual registration fee of \$35 per year or family registration fee of \$60 per year will be charged for all athletes. Yearly registration fees are non-credible and non-refundable. _____ (initial)

Monthly Tuition Fees:

The tuition fee is due on the 1st of each month. If an athlete comes one time or four times a month, the monthly tuition fee remains the same and must be paid in full. _____ (initial)

Auto-Draft Payments:

To avoid Late Fees, we highly recommend enrolling in Automatic Draft with a credit or debit card. Monthly tuition fees will be automatically drafted from your account on the 1st of each month. Athletes on Automatic Draft will receive a \$10 discount on Monthly Tuition.

If you do not choose Auto-Draft, you must still provide a credit or debit card as a back-up form of payment in the event your monthly tuition is not paid by the 15th of the month. _____ (initial)

Late Fees:

Avoid Late Fees by signing up for Auto-Draft! **A \$10 late fee will be applied on the 8th of each month to all accounts with unpaid balances.** On the 15th of the month, your back-up card on file will be charged to cover your unpaid balance. _____ (initial)

After the 16th of each month, athletes with unpaid balances will be dropped from all classes and charged a \$10 Drop Fee. Accounts must have a zero balance and pay current month's tuition to re-enroll in classes. _____ (initial)

A \$30.00 charge will be charged for all declined Auto-Drafts or returned checks. _____ (initial)

Make-Up Classes:

We DO NOT OFFER free make-up classes, but athletes can receive Open Gym passes when a class is missed. Athletes can only receive up to 2 Open Gym passes per month. Open Gym passes do not expire. 4 Open Gym passes can be redeemed for a Skill Clinic. _____ (initial)

Drop Policy:

Ultimate requires a 2-week notice to drop an athlete from their classes. You must provide written notification through email or filling out a Drop Form at the Front Desk. Your 2-week notice starts from the day the email or Drop Form is received. _____ (initial)
